**Membership in CSA** includes: one copy of each bi-annual journal; monthly e-newsletter; meeting attendance at member rates; voting privileges; CSA grants and awards eligibility; discount on CSA series publications. **Standard** \$130

**Student** \$65 - Subsidized membership for full time students. Qualifications will be assessed before this level of membership is activated.

**Emerging Professional** \$105 - Subsidized membership available for new professionals for up to three years after graduation. Qualifications will be assessed before this level of membership is activated.

**Retired/Emeritus** \$105 - Subsidized membership available for individuals who have retired or promoted to Emeritus status since their last renewal and have at least a five-year history of CSA membership. Qualifications will be assessed before this level of membership is activated.

**CSA Patron** \$155 - Includes \$25 donation, which subsidizes the discount for one Emerging Professional or Retired/Emeritus membership. The donation is tax deductible as a charitable contribution to the extent provided by law for federal income tax purposes.

**CSA Champion** \$195 - Includes \$65 donation, which subsidizes the cost for one Student membership. The donation is tax deductible as a charitable contribution to the extent provided by law for federal income tax purposes.

**Museum/Association** \$260 - Available for non-profit organizations that have multiple staff or board of director members who would like to participate in CSA activities and services. This provides eligibility for two staff or board members to receive member benefits.
